WHEREAS, the stockholders of the Corporation, during its Annual Meeting last 22 August 2015, duly ratified and confirmed the resolution of the Board of Trustees to effect a change in (a) the Corporation's fiscal year, duly delegating to the Board of Trustees the authority to determine the new fiscal year to be observed by the Corporation, and (b) the date of the Annual Meeting of the Stockholders of the Corporation;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board of Trustees of the Corporation approve, as it hereby approves, the shift in the academic term, such that the academic year will open in August of each year, beginning with school term 2016-2017;

RESOLVED, FURTHER, that, pursuant to the authority granted by the stockholders to the Board of Trustees of the Corporation, the Board of Trustees approve, as it hereby approves the following amendments to the Amended By-Laws of the Corporation as follows:

1. The amendment to Section VII of the Corporation's Amended By-Laws, changing the annual meeting of the stockholders, from the fourth Saturday of August of each calendar year to the month of October, such that the same shall now read as follows:

Section VII- ANNUAL MEETING-The annual meeting of the stockholders after the year 2016 shall be held in the month of October of each calendar year at the office of the corporation x x x

2. The amendment to Section XXXVI of the Corporation's Amended By-Laws, changing the fiscal year of the Corporation from fiscal year beginning on the first day of April and ending on the last day of March to the fiscal year beginning on the first day of June and ending on the last day of May of the following year, such that the same shall now read as follows:

Section XXXVI- FISCAL YEAR- The business year of the corporation after fiscal year 2015-2016 shall begin on the first day of June and ending on the last day of May of the following year, provided, however, that in the event the school calendar is revised in the future the business year shall end with the last day of the month in which the school year ends.
