Dear Atty. Leonardo and Atty. Negre:

In Far Eastern University's ("FEU") board meeting today, 17 June 2025, the Board of Trustees approved an additional equity investment of Eleven Million Four Hundred Twenty-Eight Thousand Six Hundred Pesos (Php 11,428,600.00) in Higher Academia, Inc. ("HAI"), an educational institution that offers secondary and tertiary education in San Fernando, Pampanga.

As a result of such investment, FEU will acquire an additional One Hundred Fourteen Thousand Two Hundred Eighty-Six (114,286) shares of common stock in HAI. After such, the total shares owned by FEU will be Two Million Nine Hundred Fourteen Thousand Two Hundred Eighty-Six (2,914,286), which is equivalent to fifty-one percent (51%) of the total outstanding capital stock of HAI. The Board likewise approved the execution of a subscription agreement, as well as any other related documents.
