Signing of a Memorandum of Agreement with Bataan Peninsula Educational Institution Inc.

Background/Description of the Disclosure

The Far Eastern University ("FEU") entered into a Memorandum of Agreement with the Bataan Peninsula Educational Institution Inc. ("BPEII"), doing business under the name University of Nueva Caceres – Bataan, and BPEII's shareholders whereby, upon completion of certain conditions to closing, FEU will purchase 76.92% of the land on which BPEII operates, at a purchase price of Fifty Million Pesos (Php50,000,000.00) and FEU will subscribe to 39,500 shares in BPEII at a subscription price of One Hundred Six Million Pesos (Php 106,000,000.00). FEU and the other landowners will subsequently transfer the land in exchange for additional shares in BPEII.
